



NABET-CWA LOCAL 21 Withdraw information & Selection Form

It is the members responsibility to contact the local if he/she leaves employment within the locals jurisdiction and they wish to withdraw. If you do not request to withdraw from the union, you will be required to pay the minimum dues per year or quarter.

When you withdraw, you will be issued a WITHDRAWAL STICKER. You must apply this sticker to your MEMBERSHIP CARD. If you fail to apply this sticker, your card will expire on the date of the last active sticker. If you gain employment within the jurisdiction of NABET-CWA, you will NOT be required to pay a new Full time initiation fee, *provided that you present your card with a valid withdrawal sticker properly applied.* (If you have only paid the partial fee, for NON-FULL TIME status, you will still owe the balance to the full time fee to Local 21, regardless of where your new job is located.) You must present the card to the local Treasurer or Secretary/Treasurer of the local which has jurisdiction over your new place of employment within 30 days of your return to work.

Failure to present your withdrawal card within 30 days of your return to the Union's jurisdiction will void the rights and privileges granted by the card, including your right to restore your active membership without paying a new initiation fee.

----- If you leave your current job, please make a choice: -----

1) [**Withdraw**] I am leaving my current job, and will not be working at a NABET-CWA represented location. Therefore, I would like to **withdraw** from NABET-CWA. I understand I will be issued a withdrawal sticker, and that it is my responsibility to apply it to my current membership card. I also understand that if I take another job at a NABET-CWA represented location, I simply present my card with withdrawal sticker, and If I have paid a full time initiation fee to local 21, I will not have to pay a new initiation fee. (If I have paid the partial fee to local 21, I will then owe the difference to a full time fee, to local 21, regardless of where the new job is located.) I understand it can take 60-90 days to process the withdraw request.

2) [**Remain Active**] I am leaving my current job, and will not be working at a NABET-CWA represented location. However, I wish to **remain active** in NABET-CWA so that I will continue to receive the CWA & NABET newspapers, as well as be able to participate in local union functions. I understand the minimum dues is \$60 per year, billed annually. If I chose to be billed quarterly, I understand the minimum will be \$20 per quarter (\$80 per year). I understand I will make that choice at the start of each year. (If I take a FULL TIME job at a NABET-CWA represented location, but have only paid the partial fee to local 21, I will then owe the difference to a full time fee, to local 21, regardless of where the new job is located.)

3) [**Transfer membership**] I am leaving my current job, but I am taking a job at another NABET-CWA represented location. If this station is not under the jurisdiction of NABET-CWA Local 21, please **transfer** my membership to the appropriate local.
